There was a discussion on 'bundling' credits; i.e. combining courses in order to grant either a half or a full credit. Most districts will do this for courses taken in the same year (like Biology, Chemistry, and Physics combined for one credit of Science), but it is not done across years (like Biology for 2 hours a week in grades 9 and 10 cannot be combined for a full credit).

11:00 – 2:00 General Meeting

- Newcomer Program presentation by Dr. Marci Rodriguez, Anne Arundel County Public Schools. Dr. Rodriguez presented the program for newcomer students with limited formal schooling and limited English proficiency held at Annapolis High School. A computer program (Leamos por Computadora) is used to teach literacy, Foundations of High School Math (ALEKS) is being piloted for math, and there is a lot of technology infused in the curriculum to help students progress in learning English and in basic academic skills. - Newcomer Program presentation by Jen Ruby, Howard County Public Schools. Ms. Ruby presented the program in Howard County that runs out of River Hill High School for newcomer students with interrupted education. - The minutes for the October meeting were discussed, and adopted without alterations.
- During lunch, the video on Family Reunification (by Arlington County) was shown. Ahmed Ousman shared his personal experience as a refugee from the Sudan, and the hardship of family separation he went through 11 years ago.
- World Education Services (WES), a credential evaluation service, presented a workshop on their services. Marybeth Sowa, the regional director explained the following:
 - WES is the largest evaluation service (non-profit), with 50,000 evaluations last year and 100 employees.
 - It has liaisons with institutions in Eastern U.S. The main office is in New York, with reps in Chicago, San Francisco, and Toronto.
 - How WES works:
 - Ensuring authenticity
 - Credential analysis

- Current issues in evaluation
- Issues that WES has been dealing with:
 - Relying on student-supplied records
 - Determining authenticity
 - Not knowing if school is 'accredited' (most countries use Ministry of Education certification)
 - WES tries to get records directly from schools when possible. Check their website to see what they require per country in order to complete an analysis of transcripts.
 - MAFSA members can call/email Marybeth Sowa for help with documents from particular countries, especially if family says they cannot get records. Students can also go to the website (wes.org/required)
 - Some questions to ask:
 - Is the school recognized by the country's Ministry of Education?
 - Is it a 'diploma mill'? There are 437 such schools on the WES database some schools may pose as distance learning institution, or their webpage may end in .edu. There is an Oregon site that is useful in determining if a college is unaccredited (a diploma mill). Check osac.state.or.us/oda/unaccredited.html
- How does WES determine equivalency?
 - o Level
 - Scope (length of course)
 - Intent (purpose of diploma in the country)
- Evaluations can by document (\$100) or course by course (credential analysis)
